1. This meeting will be known as the Escort Car Club Sprints and is promoted by the Escort Car Club committee, under the regulations MSNZ National Sporting Code, its appendices & schedules particularly App. 5 Schedule C. Standing Regs for all Club Sport Events and these Supplementary Regulations.

3. **MOTORSPORT NZ PERMIT NO. TBA** and is for a club sport category two (advanced) events-Dual car bent sprint (circuit sprint competition).
4. Racing/ practice rules are those which are known as the "OFFICAL RACING RULES", otherwise, the rules follow MotorSport NZ Regs.
5. Documentation and Scrutineering will be done on 11<sup>th</sup> June at Wally Elder Garage 271 Clyde St Hamilton or the day before at 8/298 Nielson St Onehunga Auckland. **UNLESS PREARRANGED WITH THE SECRETARY.**
6. Rechecks will be scrutineered at the track after 8.10am. Drivers briefing at 9.30am.
7. Sprint practice runs from 10:30am to 11:45am followed by lunch-30minutes. Sprint proper will start at 12:15pm and continue to 4:45pm.
8. Drivers must produce a current club membership card. **ALL COMPETITORS MUST HAVE AS A MINIMUM A `CLUBSPORT LICENCE.**
9. Immediately a car has passed over the start line after the starting flag has fallen, it will be counted as a run.
10. Flag signaling will be used as approved by the current MotorSport NZ manual .
11. The signaling will be under the supervision of the "Clerk of the Course" and the people at the observation posts at various points on the circuit.
12. Registration plates and license label must be attached to road registered vehicles. The car must have a current warrant of fitness and registration or comply with Motorsport NZ Regs.
13. Passengers: At the discretion of the Clerk of the Course (providing they hold as a minimum a Club Sport competition license if under 15 years), passengers may be carried provided the car is fitted with suitable seat, belts and roll bars. Passengers may be changed between runs. Refer to Motorsport manual , Club sport Appendix 5 All Drivers and passengers must sign the indemnity on the indemnity (doubles as indemnity form for sprints).
14. A maximum of 60 (sixty) entries will be accepted for this event. The promoter reserves the right to decline the acceptance of any particular Entry without stating a reason, and to debar a competitor from starting or continuing should the scrutineer deem the vehicle to be unacceptable. In the event of an entry being declined, the entry will be forfeited. The decision to re-scrutineer will be made by the Clerk of the Course ONLY.
15. Any Driver consuming or has recently consumed or in possession of intoxicants or has recently administered/smoked or in possession of mind degenerative drugs will be debarred from further participation, ordered from the precincts of the meeting and be reported to their club.
16. A competitor who has caused damage to property will have a claim laid against him/her for the cost of the repairs to the damaged property, or for the costs replacement or the damaged property if that is necessary. No litter is to be left at the venue.
17. Purpose built race cars must be registered with Motorsport NZ (Log book to be available). See entry form for further details required.
